SAMBHAV 2011: showcasing artistic talent of the disabled for inclusive growth

The sixth edition of SAMBHAV, showcasing the artistic talent of physically and mentally challenged artistes from 18 countries including India, concluded in the weekend of 12 & 13 November 2011 with a resounding success. The two-day festival, organised annually by A.L.P.A.N.A. Society, this year attracted groups from Australia, Bangladesh, Bhutan, Colombia, Germany, Nigeria, Indonesia, Iran, Malaysia, Mauritius, Mongolia, Myanmar, Nepal, Pakistan, Russia, Sri Lanka and Thailand besides groups from Indian States (Provinces) of Delhi, Madhya Pradesh, Mizoram and Odisha.

Felicitations

Inauguration

Mr. Wajahat Habibullah, Chairman, National Commission for Minorities, recounting his previous association with this event, said the present foray into building an international understanding in the field of inclusive arts and growth was commendable. 'SAMBHAV', which literally means- 'possible', has achieved an extraordinary feat through this effort, he said. SAMBHAV-2011 was inaugurated by Mr. Wajahat Habibullah on Saturday, the 12th of November 2011 at India International Centre. It included a series of seminars on challenged persons, an exhibition of art and craft by challenged artists and performances by twenty two

troupes from sixteen countries at two prominent venues in New Delhi, the India International Centre and the India Islamic Cultural Centre.

International Performances

The challenged performers from different countries impressed the audience with their excellence in the 2-day long International Performances segment of SAMBHAV 2011. Union Minister for Culture Kumari Selja was the Chief Guest while renowned danseuse Padma Vibhushan Dr. Sonal Mansingh presided over the function on 12 November 2011. Mr. Justice A.K. Patnaik of Supreme Court of India was the Chief Guest while Chief Central Information Commissioner Mr. Satyanand Mishra presided over the function on 13 November 2011. Indian Culture Minister Kumari Selja was particularly touched by the performance of the wheel chair bound autistic artiste from Australia and her companion. In the International Performances segment, forty-five choreographed items and compositions were presented by as many as ninety-eight challenged performers from twenty-two groups belonging to sixteen different countries.

International Coopertaion Framework

SAMBHAV 2011 set a landmark by providing a platform, where eleven Memoranda of Understanding (MoUs) were signed between the A.L.P.A.N.A. Society and organisations from eleven different countries that have been working for inclusive growth of mentally and physically challenged persons through performing arts. The objective of these MoUs is to cooperate and to share experience in the sector for mutual benefit and, also, to provide mechanisms in the countries of the signatories to undertake similar participative efforts. The MoU signing ceremony was presided over by Ambassador Mr R.M. Agrawal. These MoUs were signed with organisations from Bangladesh, Bhutan, Colombia, Indonesia, Mauritius, Mongolia, Myanmar, Nepal, Nigeria, Sri Lanka and Thailand.

International Art Exhibition

In the International Art Exhibition segment of SAMBHAV 2011, about 120 high quality paintings by challenged artists from Bangladesh, India, Malaysia, Russia, Sri Lanka and Mongolia were displayed at India International Centre. Mr Aleksandr Pushilko from Russia conducted a painting workshop. Also on display were craft items produced by challenged craft-students of A.L.P.A.N.A. Society.

International Seminar

SAMBHAV 2011 had a segment of International Seminars on the theme, "Challenged Young Persons, Mental Health and Inclusive Growth." Experts from India and abroad presented their papers and spoke in the Seminar.
